Dear State Attorney General, District Attorney, and/or Applicable Prosecuting Authority,

By way of introduction, I am Richard M. Fleming PhD, MD, JD in my 54th year of scientific research. I am a Physicist, Nuclear Cardiologist and attorney, who has been working on SARS-CoV-2 and COVID-19 since January of 2020. My work has included published research as noted in NCT04349410 in addition to investigations into the origins of SARSCoV-2. This research has since been published and presented at multiple conferences.

I am writing to request that you convene a grand jury to address crimes against humanity employing Gain-of-Function research paid for by American taxpayers and conducted throughout the United States and other countries. To help facilitate this effort, I have provided near the end of this letter, references as well as links to material needed by you to pursue indictments for the individuals who have committed these crimes. Other individuals providing corroborating evidence include inter alia, Kevin W. McCairn, PhD; Charles Rixey, WMD expert U.S. Marine Corps; Johanna Deinert, MD; and Andrew G. Huff, PhD, former Vice-President of EcoHealth.

As you review the materials you will see there are a number of Federal Crimes that have been committed. The equivalent of these Federal Criminal actions indictable under the State Statutes; include but are not limited to:

1. Murder
2. Attempted Murder
3. Manslaughter
4. Reckless Homicide

5. Reckless Endangerment
6. Assault
7. Battery
8. False Imprisonment
9. Perjury

Specifically, I am asking you to review the materials contained in the links, and the book, and then to convene a Grand Jury to indict the following individuals and organizations for these State Crimes in addition to Crimes of Conspiracy, Crimes Against Peace, and Crimes Against Humanity:

- Janet Woodcock, Commissioner, U.S. Food and Drug Administration
- F. Fleming Crim, Chief Operating Officer, National Science Foundation
- Francis S. Collins, Director, National Institute of Health
- Anthony S. Fauci, Director, National Institute of Allergy and Infection Disease
- Peter Daszak, President, EcoHealth Alliance
- Ralph S. Baric, PhD, University of North Carolina Chapel Hill
- Shi Zhengli, PhD, Wuhan Institute of Virology
- William Henry Gates III
- Bill and Melinda Gates Foundation

- Any and all other individuals found to be Criminally culpable upon investigation of these crimes, including but not limited to Presidents, present and past, of the United States of America.

The materials provided herein provide evidence that the aforementioned individuals and entities are guilty of the above noted crimes at the State, in addition to crimes at the Federal level, including but not limited to, Crimes of Conspiracy, Crimes Against Peace, and Crimes Against Humanity, for the Intentional, Knowing, Willful and Reckless violation of the following Treaties and accepted human Ethics:

- (1) the 1947 Biological Weapons Convention (BWC) Treaty,
- (2) the 1947 Nuremberg Code,
- (3) the 1964 Declaration of Helsinki,
- (4) the 1976 International Covenant on Civil and Political Rights (ICCPR) Treaty, and
- (5) the American Medical Association Code of Medical Ethics

For the individuals listed above, as well as those found to be criminally culpable following further investigation of these crimes, who have taken an Oath to Uphold and Defend the Constitution of the United States of America, and who have then violated these Treaty laws under Article VI of the U.S. Constitution, these individuals are also guilty of Treason.

You may be interested to know that a Crimes Against Humanity case has been filed with the International Criminal Court (ICC). Professor Luc Montagnier, recently deceased, Kevin McCairn PhD, and I have submitted affidavits for a multi-country ICC case. The case was submitted to the ICC on 12 August 2021 by attorneys from four countries, including the UK [Melinda Mayne and Kaira S. McCallum; 143/21], Slovakia [Peter Weis, Marica Pirosova, Erik Schmidt; 133/21], France [Patrice Lepiller,

Raphael Cohen; 271/21], and the Czech Republic [Tomas Nielsen; 326/21].

A letter of support for this ICC case was provided by Nazi Concentration Camp survivors Moshe Brown, Hillel Handler, and Vera Sharav on 20 September 2021. This ICC case is the only ICC case, I know of, that has been filed and has not been dismissed by the ICC. A corresponding petition for action has been signed by more than 71-thousand individuals.

It is critical that US citizens and agencies involved in this Gain-of-Function research be held criminally accountable in the United States. It would be problematic for the USA to have its citizens indicted by the ICC, independent of whether the US would allow extradition for such a trial.

It is incumbent upon the State Attorney Generals, District Attorneys, and/or applicable Prosecuting Authorities, to prosecute the individuals and agencies noted above, as Criminally Accountable as detailed in the following evidence, materials, and presentations provided during the CrimesAgainstHumanityTour by the signatories noted below.

The evidence and materials needed to convene a Grand Jury include but are not limited to:

- (1) The published book entitled *Is COVID-19 a Bioweapon? A Scientific and Forensic Investigation*. This book details the money, publication and patent trail of those involved.

- (2) A deposition under Oath to be used in any jurisdiction, sworn in by a bone fide Court Reporter. This deposition was obtained

by Richard Stone, Esq. who has argued and won a case before the US Supreme Court.

As did the signers and submitters of the Declaration of Independence, we the undersigned submit this Letter for Indictments, *with a firm reliance*




