United States Constitution

- The **Amendments** guarantee rights.

The **9th** Amendment & **14th** Amendment (Due Process)

- SCOTUS held personal liberty **rights** exist for **SEX, HEALTH CARE, FAMILY**, when there is History, Custom & Tradition.

The SCOTUS has repeatedly heard cases including **Griswold v Connecticut (1965)** ruling that Substantive Due Process of Personal Liberties which include **sex, health care** and **family** cannot be abridged by the Government when **History, Custom & Tradition** has granted those rights to individuals.

The Test - Does a Right Exist?

History (The Study of **past events**):

- Patients are treated by their doctor.
- Prescriptions are filled by pharmacists.
- Doctors use drugs for off-label use.

Custom (The traditionally **accepted way** of doing something):

- Government does not interfere with doctor-patient relationships.
- The doctor and patient determine care using drugs and treatments already approved.
- If you present with a health problem you will be treated.

Tradition (Passing customs and beliefs from one generation to another):

- Hippocratic and Geneva Oaths.
- To patients. Not Govt, Big Pharma, Courts, Insurance Companies, Govt. Agencies.

Three Major SCOTUS Cases to be Aware of.

In **Rochin v. California**, 342 U.S. 165 (1952), SCOTUS ruled Due Process violated under the 14th Amendment where emetic was used to forcefully empty Rochin's stomach contents to obtain two capsules he had swallowed.

In **Griswold v Connecticut (1965)** the SCOTUS ruled the Federal Government must have a “**compelling and substantial**” reason for trying to revoke rights of U.S. Citizens; rights that by History, Custom, and Tradition, belong to the people. Any law must be very tightly written. (p. 68). Govt cannot merely have a reason they want to revoke your rights.

In **Cruzan v Director, Missouri Department of Health (1990)**, the SCOTUS ruled that a **person** has the Constitutional Due Process **Right to Refuse Medical Care** and that forced care upon a patient not wanting that care constitutes **ASSAULT** upon the person (p. 79)

In **Doe v. Rumsfeld** 341 F. Suppl 2d 1 (D.D.C. 2004) where SCOTUS ruled “Congress has prohibited the administration of investigational drugs to service members without their **consent**. It is illegal absent informed consent or a **Presidential waiver**.”

United States Constitution

Article VI –Paragraph 2 Recognizes The Constitution, and **Treaties** as the **Supreme Law of the Land**.

- **1975** Biological Weapons Convention (**BWC**) Treaty

- **1967** International Covenant on Civil and Political Rights (**ICCPR**) Treaty
- **Both** violated by the **Gain-of-Function** research resulting in SARS-CoV-2 spike protein and this pandemic.
- **ICCPR** violated by experimenting on people without prior **animal studies** and without **Informed Consent**.
- Also a violation of the AMA code of Ethics to give drug without informed consent. Which is impossible to do given blank package inserts.

Erosion of our rights and abuse of power has been going on for **decades** and **accelerated** since 2020 by those elected and appointed but not elected:

- 1) Gain-of-Function violation of BWC Treaty;
- 2) Interference with medical treatment;
- 3) Loss of travel and movement (quarantining the healthy);
- 4) Loss of right to gather;
- 5) Loss of right to gather to practice religion;
- 6) Loss of right to earn a living: life, liberty and pursuit of happiness;
- 7) Loss of personal health care choices/informed consent reminiscent of **Nazi Germany**;

- 8) Manipulation using Fear (Benjamin Franklin: **a society that will give up liberty to gain security will deserve neither and lose both**);
- 9) Loss of right to resist assault upon our bodies, the bodies of our children, our parents, and those we hold dear to us; through the forced coercion of an Experimental Vaccination program;
- 10) Which does not change when FDA gives full approval – as EUA shows no statistical benefit and significant harm/death.

The last few decades have shown unbridled abuse of power and violation of the BWC Treaty placing this country and every country at risk; with more than \$60 Million funneled to Peter Daszak (EcoHealth), Ralph Baric at UNC and Shi Zhengli-Li at WIV from

the (USAID) U.S. Agency for International Development,
the Department of Homeland Security,
the Department of Commerce,
the Department of Agriculture,
the Department of the Interior,
the National Science Foundation,
the (NIH) National Institutes of Health,
the (NIAID) National Institute of Allergies and Infections
Diseases, and
the (DOD) Department of Defense

In addition the DOD provided a Policy Advisor to Peter Daszak – former Fort Detrick Commnader David Franz.

- This information, grants, published research, patents, will all be released on 7 September 2021 in

“Is COVID-19 A Bioweapon? A Scientific and Forensic Investigation”

It should also be noted that in addition to money the DOD also provided a Policy Advisor and former Fort Detrick Commander (David Franz), to Peter Daszak at EcoHealth.

- Same people: Gain-of-Function, Blocking medical treatment, drug vaccines, and other experimental work.
- They also contribute heavily to Colleges/Universities.

The Drug Vaccines

- Based upon the EUAs the drug vaccines do not reduce COVID cases or deaths.
- The drug vaccines cause SHEDDING (FDA/HHS: August 2015 Guidance for Industry Report entitled: “Design and Analysis of Shedding Studies for Virus and Bacteria-Based Gene Therapy and Oncolytic Products.”
- The drug vaccines cause harm and death.
- The drug vaccines and the Gain-of-Function virus cause Inflammation, Blood Clotting, Heart Disease, and death just as I explained in the Theory I

introduced at the **1994 AHA** meetings, published in a Cardiology **Textbook 1999** and presented on **20/20** in **2004**.

Problems with VAERS

- Codes for adverse events to other vaccines but not SARS vaccines. No Computer record.
- Physician call in number give message only.
- Computer submissions kicked out.

As of **10 July 2021** for the three Drug Vaccines given EUA clearance for experimental use in U.S. Citizens the Vaccine Adverse Events Reporting System (VAERS) shows:

438,440 Adverse Events

26,818 Hospitalizations (bearing in mind there is no ICD-10 code to acknowledge vaccine problems)

7,463 Disabled Problems reported

3,324 Myocardial Infarctions (Heart Attacks)

2,200 Myocarditis (Heart Inflammation)

985 Miscarriages, and

9,048 Deaths

- 1% or 10% of drug vaccine adverse events gets reported to the Vaccine Adverse Events Reporting System (VAERS) is meaningless.

- The arguments and debates about whether it is 9,000, or 12,000, or 45,000 are meaningless.
- Isn't 9,000 deaths from these vaccines enough?
- Isn't half a million adverse events enough?
- Isn't more than 5,000 cases of heart damage enough?
- How much is too much?
- The SARS-CoV-2 virus and the spike protein resulting from Gain-of-Function research is by definition a BIOWEAPON.
- The vaccines that genetically code for or put this spike protein into the body are therefore also by definition a BIOWEAPON.

The Consequences of Un-Bridled Power

- Experimentation in Nazi prisoner of war camps.
- Japanese internment camps in USA
- Conscientious objector starvation experiments in the USA.

Resolve to not repeat

- 1947 Nuremberg Code
- 1964 Declaration of Helsinki
- 1967 ICCPR Treaty
- 1975 BWC Treaty
- Various Medical Codes of Ethics including AMA

All violated by people who have abused their power and violated the Oaths taken to this Country.

- Not only have the people who have been involved with the Gain-of-Function research violated their oaths;
- But they have violated their Oaths to this Country and the Constitution.
- By definition TREASON
- Punishable by DEATH.

Limitations to Government Power and Swine Flu

- The U.S. Constitution **does not give** these agencies or the Three Branches of the Federal Government (Legislative, Executive, Judiciary) the power to practice or control medicine, medical treatment, or the right to coerce you to inject experimental drug vaccines into your body.
- The Government tried scaring people during the mid-1970s with **Swine Flu**, and lied to the

American public about celebrities endorsing and taking the Swine Flu Vaccine. The American public and Main Stream Media including 60-minutes demanded answers and called for the Experimental Swine Flu Vaccine to be stopped after 25-deaths.

- Where is our Main Stream Media today?
- During his 1947 Nuremberg Trial Herman Wilhelm Göring told American prosecutors

... it is the **leaders** of the country who **determine** the **policy** and it is always a simple matter to **drag the people** along, whether it is a democracy or a fascist dictatorship or a Parliament or a Communist dictatorship.
